Hello,

Daciana told me to contact you. I am a person with diagnosed ASD. Since my first week in game I am being harassed by few players, who destroy my fences, dig giant holes in my deed perimeters or create building plans to prevent me from leveling the ground. Yesterday I had to perform some road work to make use of all the tiles of my deed. I have opened alternative road at the same distance to allow the access to the sea while the work is being conducted, it was never planned to last more than 2 days and the mayor of their village was informed about. They called Daciana, she was blaming me for the whole situation, even if the road work is allowed even on highways and told me to fix the road immediately, even the part I never conducted any work on. She never instructed me that I am forbidden from talking to a player named Merfin. She told me "to leave them alone" which is very vague, especially that they were talking to me freely. And now, after two weeks of complaints about harassment I got banned for harassment. Please help me.

It was weird, I was asked "leave alone" people who were constantly trespassing my deed perimeters, while I wasn't trespassing theirs.


I didn't ask for any "allowances" I asked to clear, simple communication and revoking this ban as I am 100% sure it was undeserved.
