Hi,

I know you are busy, but please, do something about Badvoc. This person bullied and grieved me since my first weeks in game, he destroyed my fences, dug giant holes in my perimeter, his friend was building house plans like one tile behind my perimeter to stop my improvements, not to mention he and his friends bullied also my guests and friends including staff members such as Lyhrinae. He left the area because he didn't like the GM orders that were in favour to me. This case was reviewed by Enki, and he said he can't see anything wrong in my behaviour. I reported multiple posts of him where he spreads blatant lies about me, such that I was breaking into people structure, stealing, scamming and "everyone left because of me". None of is true. I actually brought several old players back, such as the mayors of Astrix and Shallows, with whom I formed a new alliance. Actually one of them who moved around Club Market pestered my ally and made him sell his deed and move out. Please, could you help me?

Hi,

I am aware of your various encounters with the GM team. The issue I have here is that there are clearly two sides to this story, and the moderation teams are not here to sift the truth out of arguments between players. Your reputation is your own, and we will not intervene in that. Regarding Badvoc's postings, he has generally been respectful and measured in telling his side of the story; I note he doesn't actually mention you directly in the most recent post you reported. This is within the rules, as is you responding in a measured, respectful manner. We will only get involved where a spat between players threatens to derail another thread, or where it moves beyond discussion and degenerates into personal attacks and mud-slinging.

The moderation team is not going to be drawn into a he-said-she-said argument between players. If you wish to post your side of the story, you are welcome to do so in a mature, respectful manner; this is not against the rules, so long as it doesn't cause issues elsewhere (I suggest creating your own thread if wish to do this). Be aware, there is nothing to stop others giving their side of the story, or their opinions.

My recommendation is that you ignore Badvoc and move on. There is an ignore function on the forums (under your account menu, in the drop-down at the top right of all pages), which may help with this. If you believe you are being grieved or have evidence of rule-breaking in-game, you should contact support staff via /support, in line with previous instructions from the GM team.

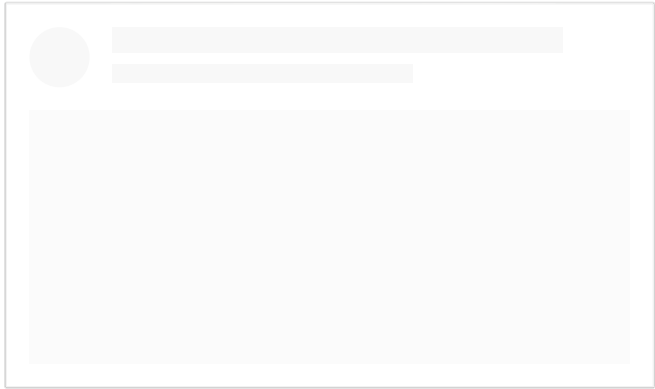
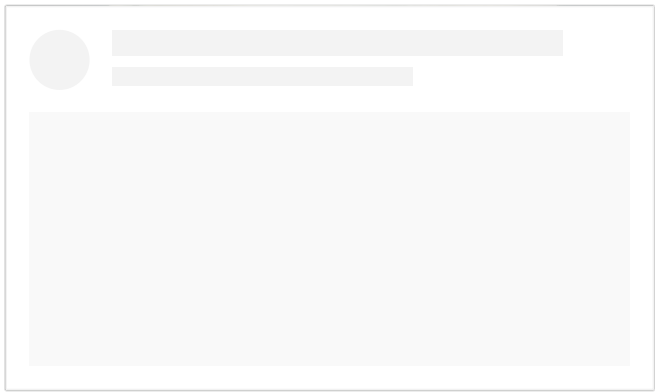

Hi, I had encounters because I had to call GMs e.g. to stop destruction of my pens. And I have multiple witnesses what was going on in R20 and there is also a ticket archive. I also called GMs to clarify the rules or to report various bugs, e.g. undestructible waystones after planting the wagoner container, and I always consulted with CAs if I should call a GM for a particular case, so is a bad thing I had encounters with a GM team?

He does post direct personal attacks, but he edits the posting after they sit for a while. Do you maybe have access of previous versions of the posts? I didn't make screenshots, but he directly accused me e.g. that I was breaking into other people pens, and yes, he is trying to destroy my reputation.

As an ASD person I am a really easy target for trolling, such people like me have a real problem spotting a deception.

Here he attacks me personally, calls ASD an "illness" that I am using as a free pass to break the game rules (I don't even have a single moderator warning, I was banned for 3 days because I made a road improvement suggestions to a person I didn't know I am not allowed to talk with, and he tells things that never happened on a public forum on a completely unrelated thread:



Other he edited but enough people read them, to know I am a thief, a scammer etc. Unfortunately I didn't make the screenshots.

Please, make him to leave me alone. I do play the game to relax and forget about some bad things happening in my life now, I really don't want to read I am a scammer, a thief and I have an "illness". I am really a big fan, but he ruins the fun to me since my first days here.

As per what I said above, he is entitled to tell his side of the story, as are you. We have reviewed every post you have reported, as we review every reported post, and no rules are being broken. I realise this is not what you want to hear, but it is not up to the moderation team to police reputations.

I encourage you to re-read what I posted in the thread you've linked, as it echoes exactly what I said above. Your dispute with Badvoc was derailing that thread, as that wasn't the place for it; you can try to work

it out with him directly in PMs, or you can move it to your own thread. Or, as per my message above, you can avail yourself of the ignore feature of the forum, and ignore him.

Even if I were prepared to step into this argument you apparently have with others, there is no way of telling exactly what the truth is, and who is right or wrong. I can only operate within the rules, and so far, aside from some thread derailing, there has not been a breach of them.

There will always be people you disagree with or don't get on with. That is not something that the moderation team can, or will, get involved in, so long as it remains within the rules.

So, to clarify, it isn't against the rules to derail threads (mind that first off-topic is always his) and it is also not against the rules to post derogatory content without proof? So I can legally post on forum, even in unrelated threads that a player X steals and scams and I don't have to produce any evidence to support this claim?

It is not about disagreeing, it is about a user A derailing user B posting false, unproven derogatory content. I am a scientist IRL, a respected member of society, I really have no problem with people disagreeing with me. I just hoped I will be able to post on forums without being insulted and my name tainted in nasty ways.

I am really deeply disappointed by this interpretation as this gives a free pass to bullies and abusers to post whatever they want about a person they dislike, not to mention this person has a long history of bullying me which is in the ticket archive. You can check yourself or ask Lyhrinae who was a witness.

Not going to argue with you, as you will probably not appreciate it, but this was unexpected and made me very discontent, also know that ignoring bullies doesn't help, they get even more nasty.
